

**WHEATLAND TOWNSHIP, WILL COUNTY ILLINOIS**  
**TAX LEVY ORDINANCE - TOWN FUND**  
**ORDINANCE No. 22-05-O**

An ordinance levying taxes for all town purposes for Wheatland Township, Will County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Wheatland Township, Will County, Illinois as follows:

SECTION 1: That the sum of Nine Hundred and Six Thousand Three Hundred and Forty Nine Dollars (\$906,349) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:



SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

**CERTIFICATION OF TAX LEVY ORDINANCE**


