

**WHEATLAND TOWNSHIP, WILL COUNTY ILLINOIS**  
**TAX LEVY ORDINANCE – ROAD DISTRICT**  
**ORDINANCE No. 22-06-O**

An ordinance levying taxes for all town purposes for Wheatland Township, Will County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Wheatland Township, Will County, Illinois as follows:

SECTION 1: That the Highway Commissioner of Wheatland Township Road District on December 8, 2022, does hereby determine and declare that the sum of One Million Nine Hundred and Seventy One Thousand Sixty Five Dollars (\$1,971,065) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute and voted by the people in accordance with the law, for such purposes as:

General Road Fund  
Permanent Road Fund

For the year 2022.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of Will, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for the road purposes for Wheatland Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portions of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.






