Notice of Proposed Property Tax Increase
Wheatland Township Road and Bridge Funds

1. A public hearing to approve a proposed property tax increase for Wheatland Township Road and Bridge Funds for 2024 will be held on December 12th, 2024 at 6:30 p.m. at the Wheatland Township Town Hall, 4232 Tower Court Naperville, Illinois 60564

2. The Road and Bridge and Permanent Road taxes extended or abated for 2023 were \$ 2,100,109.34. The proposed Road and Bridge and Permanent Road property tax to be levied for 2024 are \$ 2,175,728.00. This represents a 3.60 percent increase over the previous year.

3. The property taxes extended for debt service and public building commission lease for 2023 were zero (\$0.00). The proposed property taxes extended for debt service and public building commission lease for 2024 is \$0.00. This represents a zero (0%) increase over the previous year.

4. The total property tax extended or abated for 2023 were \$ 2,100,109.34. The estimated taxes levied for 2024 are \$ 2,175,728.00. This represents a 3.6 percent increase over the previous year.

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE No. 24-04-O

An ordinance levying taxes for all road purposes for Wheatland Township Road
Will County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Wheatland Township
Will County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Wheatland Township Road District
on December 12th, 2024 does hereby determine and declare that the sum of Two Million One Hundred Sev
Thousand Seven Hundred and Twenty Eight and 00/100 Dollars (\$ 2,175,728) are hereby levied upon all
property subject to taxation within the Road District as that property is assessed and equalized, in order to meet
and defray all the necessary expenses and liabilities of the Road District as required by statute or voted
by the people in accordance with the law, for such purposes as: General Road Fund and the Permanent Road Fund
for the year 2024.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
