Wheatland Township General Town Fund

1. A public hearing to approve a proposed property tax for Wheatland Township Town Fund for 2023 will be held on December 12th, 2024 at 6:30 p.m. at the Wheatland Township Town Hall, 4232 Tower Court Naperville, Illinois 60564

2. The corporate and special purpose taxes extended or abated for 2023 were \$ 964,201.14. The proposed corporate and special purpose property tax to be levied for 2024 are \$964,201.00. This represents a 0.00 percent increase from the prior year.

3. The property taxes extended for debt service and public building commission lease for 2023 were zero (\$0.00). The proposed property taxes extended for debt service and public building commission lease for 2024 is \$0.00. This represents a zero (0%) increase over the previous year.

4. The total property tax extended or abated for 2023 was \$964,201.14. The estimated taxes levied for 2024 are \$964,201.00. This represents a 0.00 percent increase from the prior year.

TAX LEVY ORDINANCE - TOWN FUND

ORDINANCE No. 24-03-O

An ordinance levying taxes for all town purposes for Wheatland Township, Will County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Wheatland Township, Will County, Illinois as follows:

SECTION 1: That the sum of Nine Hundred Sixty Four Thousand Two Hundred and One and 00/100 Dollars (\$ 964,201.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: General Corporate for the year 2024.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
